




ORDINANCE NO. 2023-095

AN ORDINANCE DECLARING NOVEMBER 17 OF EVERY YEAR AS STUDENTS' DAY IN THE CITY OF MUNTINLUPA, AND ADVOCATING FOR STUDENT PARTICIPATION IN NATION-BUILDING

WHEREAS, Section 11 of Article II of the 1987 Constitution, declares that, "The State values the dignity of every human person and guarantees full respect for human rights;"

WHEREAS, Section 13 of Article II of the 1987 Constitution, provides that, "The State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being. It shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs;"

WHEREAS, Section 17 of Article II of the 1987 Constitution, mentions that, "The State shall give priority to education, science and technology, arts, culture, and sports to foster patriotism and nationalism, accelerate social progress, and promote total human liberation and development;"

WHEREAS, Section 2 of Republic Act 11369 expresses that, "The State recognizes the value of inculcating love of country and social responsibility among the youth, and supports the observance of International Students' Day which was spearheaded by the International Students' Council in 1941 to commemorate the execution of nine (9) Czechoslovakian students who fought against the Nazi

ccupation;"

WHEREAS, in the Philippines, most especially in the City of Muntinlupa, the youth participation in schools and their communities which contribute to the betterment of the society are worthy of recognition and honor on the occasion of the Students' Day;

WHEREAS, Student Leadership is part of the "7K Agenda" under "Karunungan", and "Katarungan" of the Administration of *Mayor Rozzano Rufino B. Biazon;*

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 10th Sangguniang Panlungsod of Muntinlupa, in the session assembled that:

SECTION 1. *Short title* — This Ordinance shall be called the "Students' Day Celebration Ordinance."

SECTION 2. *Students' Day* — The City Government of Muntinlupa hereby declares November 17 of every year as "Students' Day" in the City of Muntinlupa.

SECTION 3. *Students' Day Activities* — As may be determined by the City Government of Muntinlupa; the Youth Affairs and Sports Development Office, the Local Youth Development Council, together with the different stakeholders, may conduct the following activities:

- (a) Education Summit May be held once every three years to gather various stakeholders to discuss the issues and concerns in the Education Sector with the goal of developing Education Policies;
- (b) **Trainings, Seminars, and Workshops** Trainings, Seminars, and Workshops for Capacity Building of various education stakeholders;
- (c) Student Leadership Forum The City Council, Local Youth Development Council, and/or Sangguniang Kabataan may provide a platform to discuss topics that would benefit the students, and their communities;
- (d) Recognition of Student Leaders; The City Government of Muntinlupa may recognize outstanding student leading to activities for school participation in nation building;
- (e) Student Competition; Student competitions may be held at Schools in celebration of Students' day;

(f) Other activities that may be suggested by the students;

SECTION 4. *Venue* — The City Government of Muntinlupa may provide a venue for the activities that are held in celebration of Students' Day. The venue may be in the Muntinlupa City Hall Quadrangle, or any other location in Muntinlupa City.

SECTION 5. *Scope* — The National Students' day is included in the DepED Annual Activities and shall be observed every November 17. The Education Sector, all public and private schools, all local and national government employees, and all Barangays within the jurisdiction of Muntinlupa shall participate in this event.

SECTION 6. *Implementing Rules and Regulations* — The Youth Affairs and Sports Development Office (YASDO), together with the Local Youth Development Council (LYDC), and the Youth Formation Division of the SDO Muntinlupa and other concerned offices of government that may be determined by the YASDO, shall formulate the implementing rules and regulations of this Ordinance within ninety (90) days after its approval.

SECTION 7. Coordination with the National Government — Celebration of the Students' Day shall be done in coordination with the National Youth Commission (NYC), Department of Education (DepEd), Commission on Higher Education (CHED), Technical Education and Skills Development Authority (TESDA), and other concerned government offices.

SECTION 8. Separability Clause. — If any provision of this Ordinance shall be held unconstitutional or invalid, the other provisions not otherwise affected shall remain in full force and effect.

SECTION 9. Effectivity Clause — This Ordinance shall take effect upon approval of the City Mayor.

ENACTED, by the 10th Sangguniang Panlungsod of Muntinlupa, this 3rd day of July, 2023, on its 52nd Regular Session.
