WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that **“(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.”**;

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, **“Unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.”**;

WHEREAS, the **CGM** pursuant to its mandate to promote the general welfare of its constituents, endeavor to grant/donate unto the Bureau of Fire Muntinlupa Fire Station one (1) unit Basic Life Support Ambulance to be used by the BFP-Muntinlupa in the emergency needs and response during and in the aftermath of fire and other disasters;

WHEREAS, the City Government of Muntinlupa as the registered owner of Basic Support Ambulance, particularly described as follows:

Shall transfer ownership thereto to the BFP-Muntinlupa, gratuitously, free and clear of all liens and encumbrances subject to the following conditions:

- Register the said vehicle upon execution of the Deed of Donation and every year thereafter;
- Provide a designated and authorized driver, diesel, manpower and other equipment to fully utilize the ambulance;
- Agrees at its own expense to clean, maintain, repair, replace and safe keep the ambulance and its accessories, to store the said ambulance in a secure and accessible location and to make regular inspection and preventive maintenance measures to the ambulance to preserve it;
- That the Muntinlupa City Department of Disaster Resilience and Management conduct quarterly monitoring and audit of the donated ambulance and make a report to check compliance of the BFP with the above-cited obligation;
- The BF-Muntinlupa City assigns an accountable official/employee to take responsibility for the custody, proper care and maintenance of the ambulance.

WHEREAS, the said donation conforms to the **Kalusugan at Kapayapaan/Kaayusan Program**, one of the **7K Agenda** of the present administration;

WHEREAS, the City Legal Office has no objection to the Deed of Donation, subject to compliance with the pertinent guidelines on auditing and accountability particularly on receipt and recording and assets inventory;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to authorize the **City Mayor Hon. Rozzano Rufino B. Biazon** to represent Muntinlupa City In A Deed Of Donation (DOD) of one (1) unit Basic Life Support Ambulance in favor of the Bureau Of Fire-Muntinlupa City.
