WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, "**Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare**";

WHEREAS, pursuant to Article 99, 2(i) of the LGC Implementing Rules and Regulations, the Sangguniang Panlungsod, "**Shall approve the annual and supplemental budgets of the City government and appropriated funds for specific programs, projects, services and activities of the city, or for other purposes not contrary to law in order to promote the general welfare of the City and its inhabitants**";

WHEREAS, in a Joint circular issued by the DBM-NEDA-DBM-DOF No. 1 Series of 2007 or the **Guidelines on the Harmonization of Local Planning, Investment Programming, Revenue Administration, Budgeting and Expenditure Management**, the Local Development Councils shall cull out the Annual Investment Plan (AIP) from the current slice of the Local Development Investment Plan (LDIP), which upon approval by the Sanggunian, shall serve as the basis for preparing the executive budget;

WHEREAS, the LDIP is a program to allocate the investible portion of the annual general fund budget for funding the development programs, projects, and activities identified in the Comprehensive Development Plan (CDP). The City Government of Muntinlupa's CDP 2017-2023 is the sectoral plan of the approved Comprehensive Land Use Plan (CLUP) 2016-2026;

WHEREAS, the AIP is the annual slice of the Local Development Investment Plan/Executive-Legislative Agenda (LDIP/ELA) referring to the indicative yearly expenditure requirements of the LGUs programs, projects and activities (PPAs) to be integrated in the annual budget;

WHEREAS on June 27, 2023, the **City Development Council (CDC)** issued **Resolution No. 1 s. 2023** or a resolution approving the **Annual Investment Program (AIP)** of the City of Muntinlupa for Fiscal Year (FY) 2024. The same AIP is aligned with the CLUP, CDP and other pertinent sectoral development plans, as well as priority programs guided by the Local Chief Executive's **7K Agenda** namely:

1. **Katarungan**
2. **Karunungan**
3. **Kalusugan**
4. **Kaunlaran**
5. **Kapayapaan/Kaayusan**
6. **Kabuhayan**
7. **Kalikasan**

WHEREAS, the Summary of PPAs for Fiscal Year 2024 are enunciated in the AIP per Development Sectors to wit:

- a. **Economic Development Sector**
- b. **Social Development**
 - i. **Education Sub-Sector**
 - ii. **Health Sub-Sector**
 - iii. **Protective Services Sub-Sector**
 - iv. **Social Welfare Sub-Sector**

- c. **Land Use and Infrastructure Development**
- d. **Environmental Management**
- e. **Institutional Development Sector**
- f. **General Programs Sector**






