AN ORDINANCE FOR THE REALLOCATION AND RECLASSIFICATION OF POSITIONS IN THE PAMANTASAN NG LUNGSOD NG MUNTINLUPA (PLMun) AND COLEGIO DE MUNTINLUPA (CDM) TO COMPLY WITH THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) CIRCULAR NO. 2007-6 AND DBM LOCAL BUDGET CIRCULAR (DBM LBC) NO. 137

WHEREAS, Section 458 (a) (VIII) of the Republic Act No. 7160, otherwise known as the Local Government Code (LGC) of 1991 provides that, "*the Sangguniang Panlungsod is empowered to determine the positions, salaries, wages and other emoluments and benefits of officials and employees, paid wholly or mainly from the city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government*";

WHEREAS, Article 163 of Rules and Regulations implementing the LGC of 1991, provides that, "*the local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its priority, need service requirements and financial capabilities, consistent with the principles of simplicity, efficiency, economy, effectiveness, dynamism and public accountability subject to the minimum standards and guidelines prescribed by the Civil Services Commission (CSC)*";

WHEREAS, Article 164, supra, provides that, "*an LGU may reorganize through sanggunian its present organizational structure or alter its present staffing pattern in accordance with laws pertinent to government reorganization and implementing rules and regulations*"

WHEREAS, on February 2007, the DBM issued Circular Letter No. 2007-6 or the Manual on Position Classification and Compensation which aims to inform DBM's clientele the position classification and compensation policy guidelines, rules and regulations, and procedures so that at their end, they could have informed bases for making appropriate decisions;

WHEREAS, DBM LBC No. 137 (Index of Occupational Services, position titles and salary grades in the Local Government (IOS-LGU), Calendar Year 2021 Edition), a component of the Compensation and Position Classification System of the Philippine Government, is being updated pursuant to the mandate of the DBM as the administrator of the Compensation and Position Classification System (CPCS) established under **Republic Act No. 6758, s. 1989**, as amended, and its authority under Administrative Order No. 42, s. 1993 to continue to prescribe policies, standards, and rules on compensation and position classification in the local government;

WHEREAS, on January 23, 2023, DBM notified the City Government of Muntinlupa of the results of its review of the 2023 Executive Budget, citing: "the following positions reflected with SG 24 shall be reallocated upon vacancy to SG 22 to conform with the appropriate SG level (SG 22) below the rank of an assistant department head for HUCs pursuant to CL no. 2007-6:

c. University Researcher V;

WHEREAS, further, DBM cited: all positions in the LGUs shall be classified into their proper position titles in accordance with LBC No. 137, in particular the following positions not reflected in the LBC found in the Colegio de Muntinlupa:

Senior Education Program Specialist and Education Program Specialist II;

NOW THEREFORE, BE IT ORDAINED, by the **10th Sangguniang Panlungsod of Muntinlupa**, in Session Assembled that:

SECTION 1. Title – This ordinance shall be known as the **reallocation and reclassification of positions in the PLMun and CDM**, respectively.

SECTION 2. Reallocation in the PLMun. To conform to DBM CL No. 2007-6, the following position is hereby reallocated:

SECTION 4. The reclassification and reallocation herein shall be reflected in the **2023 Executive Budget** and shall be included in the preparations of succeeding annual appropriations in the personnel schedule of the CGM;

SECTION 5. Separability Clause – If, for any reason or reasons, any part or provisions of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.


SECTION 6. Repealing Clause. All previous ordinances inconsistent with this ordinance shall be deemed repealed or modified accordingly.

SECTION 7. Effectivity Clause – This ordinance shall take effect after its completion of its publication in a newspapers of general circulation.




