KARA MAGSANOC-ALIKPALA, ON THE MATTER OF IMPLEMENTING THE ATING DIBDIBIN PROGRAM WHICH INCLUDES CLINICAL BREAST EXAM, PATIENT NAVIGATION, AND THE USAGE OF THE ATING DIBDIBIN DIGITAL PLATFORM

WHEREAS, Sec 11 of the Philippine Constitution provides, *"The State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost. There shall be priority for the needs of the underprivileged sick, elderly, disabled, women, and children. Xxx;*

WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, *"every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";*

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing the LGC (LGC-IRR), provides that, *"(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City, and in this connection, shall: Xxx (vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";*

**WHEREAS**, ICanServe Foundation, Inc. (ICS) is a Philippines-based advocacy group of breast cancer survivors and volunteers. It co-creates breast cancer control programs with local government as part of its initiative to promote early breast cancer detection, access to accurate diagnosis and timely treatment, survivorship care, palliative care, hospice care and patient navigation.

**WHEREAS**, The ICS created its first community-based breast cancer screening program in the Philippines, Ating Dibdibin which was launched under the auspices of the American Cancer Society and with a grant from Pfizer Foundation (USA) and Pfizer Foundation Philippines. The program facilitated treatment of all women diagnosed with breast cancer during the screening period and aims to make the early detection program permanently included under the local government's health budget:

**WHEREAS**, the City Government of Muntinlupa, through its Gender and Development (GAD) has taken the lead in championing women's health and wellness through its various programs and projects in collaborations with various non-government organizations and foundations;

**WHEREAS**, the Memorandum of Agreement (MOA) with the ICS foresee a web-based data infrastructure through Dashlabs.ai a single, end-to-end platform for automating and optimizing healthcare and medical diagnostic lab operations including integration with any lab machine; training of Barangay Health Workers (BHW) on the use of the different features of the online data infrastructure and on the conduct of clinical breast examination;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the **10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa**, to authorize the **Hon. City Mayor Rozzano Rufino B. Biazon**, to represent the City Government Muntinlupa in a **Memorandum of Agreement (MOA)** with **ICANSERVE Foundation Inc., (ICS)** represented by its Founding President, **Ms. Kara Magsanoc-Alikpala**, on the matter of implementing the **Ating Dibdibin Program** which includes clinical breast exam, patient navigation, and the usage of the **Ating Dibdibin Digital Platform**.

**ADOPTED**, by the **10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa** this **17<sup>TH</sup>** day of **July 2023**, on its **54<sup>th</sup> Regular Session**.
