- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of Nine Hundred Eighty Nine Thousand Eight Hundred Thirty Seven Pesos & 30/100 (P989,837.30) or such other sums as may be ascertained, VICTORY 77 VENTURES agrees to the Supply & Delivery of Medical Supplies, Materials & Rescue Equipment Intended for Muntinlupa Aquatic Center in accordance with his/her/its Bid.
- 4. The City Government of Muntinlupa agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


