Contract Agreement

THIS AGREEMENT made the AUG 30 2023 day of _____ 20____ between **CITY GOVERNMENT OF MUNTINLUPA** of the Philippines (hereinafter called "the Entity") of the one part and **TIGER CONSULTING & SOFTWARE DEVELOPMENT INC.** with address at Makati City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the **Network Security Licenses for the Protection & Prevention of Threats & the like on All Systems, Applications & Software of the City Government of Muntinlupa** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Nine Hundred Twelve Thousand Six Hundred Forty One Pesos & 80/100 (P912,641.80)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;



- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of **Nine Hundred Twelve Thousand Six Hundred Forty One Pesos & 80/100 (P912,641.80)** or such other sums as may be ascertained, **TIGER CONSULTING & SOFTWARE DEVELOPMENT INC.** agrees to the **Network Security Licenses for the Protection & Prevention of Threats & the like on All Systems, Applications & Software of the City Government of Muntinlupa** in accordance with his/her/its Bid.
4. The City Government of Muntinlupa agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.



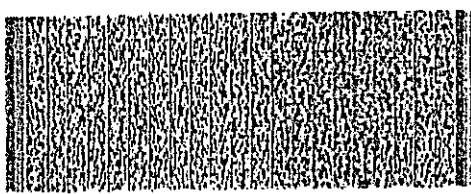
