AN ORDINANCE ON THE APPROVAL OF THE REVISED LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND (LDRRMF) INVESTMENT PLAN CONTAINING THE PROGRAM TO UTILIZE A PORTION OF THE UNEXPENDED BALANCE OF THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT (LDRRM) SPECIAL TRUST FUND (STF) FOR THE YEAR 2020, IN THE AMOUNT OF FORTY SEVEN MILLION ONE HUNDRED SIXTY-SIX THOUSAND SIXTY-TWO PESOS AND 50/100 (PHP47,166,062.50)

**WHEREAS**, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, **"every Local Government Unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;"**

**WHEREAS**, Section 2(l) of the Philippine Disaster Risk Reduction and Management Act of 2010 (R.A. No. 10121) declares that, **"it is the policy of the State to recognize and strengthen the capacity of the LGUs and communities in mitigating and preparing for, responding to, and recovering from the impact of disasters,";**

**WHEREAS**, Section 21 of R.A. No 10121 provides that, **"the creation of the local calamity fund known as the Local Disaster Risk Reduction and Management Fund (LDRRMF) to support disaster risk management activities. Further, the unexpended LDRRMF shall accrue to a special trust fund solely to support said activities within the next five (5) years";**

**WHEREAS**, paragraph 2.5.6 of Department of Budget and Management (DBM) LBC No. 2020-124 pursuant to Section 21 of R.A. No. 10121 and its Implementing Rules and Regulations (IRR), Commission on Audit (COA) Circular No 2012-002, and National Disaster Risk Reduction and Management Council-Department of Budget and Management-Department of Interior and Local Government (DILG) Joint Memorandum Circular (NDRRMC-DBM-DILG JMC) No. 2013-01, states that, **"The unexpended balances of the LDRRMF that accrued to the Special Trust Fund pursuant to Section 21 of R.A. No. 10121 may be used to address the disaster response requirements x x x, provided that the same is consistent with the approved LDRRM Plan as incorporated in the Annual Investment Plan (AIP)";**

**WHEREAS**, paragraph 65 of the NDRRMC-DBM-DILG JMC No. 2013-01 provides that, **"The unexpended balances of the LDRRMF may be released and utilized for new expenditure items as approved by the local Sanggunian and Local Chief Executive upon recommendation of the Local Disaster Reduction and Management Office (LDRRMO)";**

**WHEREAS**, the unexpended balance of the **LDRRMF (Special Trust Fund)** for the year 2020 amounted to **Fifty Million One Hundred Twenty-Seven Pesos and 73/100 (Php50,000,127.73)** according to the submitted Revised STF AIP form;

**WHEREAS**, the LDRRM Council on November 24, 2022, during its 4<sup>th</sup> meeting, adopted Resolution No. 17, s. 2022 which recommended the Revised Local Disaster Risk Reduction And Management Fund Investment Plan Containing the Program to Utilize the a portion of Unexpended Balance Of The Local Disaster Risk Reduction and Management (LDRRM) Special Trust Fund (STF) For the year 2020, in the amount of **Forty Seven Million One Hundred Sixty-Six Thousand Sixty-Two Pesos And 50/100 (Php47,166,062.50);**
