AN ORDINANCE GRANTING THE TOTAL AMOUNT OF EIGHTY THOUSAND PESOS (PHP80,000.00) OF FINANCIAL ASSISTANCE TO THE SIXTEEN (16) FAMILIES AFFECTED BY FIRE ON AUGUST 1, 2023 AT NO. 127 & 178, BAUTISTA ST. PUROK 3, BARANGAY BAYANAN, MUNTINLUPA CITY

WHEREAS, Section 16 of the Local Government Code of 1991 states that *“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*:

WHEREAS, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, *“The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx”*;

WHEREAS, on **August 1, 2023** Seven (7) structures, housing sixteen (16) families, were gutted by fire at No. 127 & 178, Bautista St., Purok 3, Barangay Bayanan, Muntinlupa City;

WHEREAS, in a final report rendered by the **Social Services Department** on **August 2, 2023**, and received by the **SP Secretariat Office** on **August 10, 2023** the following were noted as casualties of the said fire:

1. **Seven (7) structures;**
2. **Sixteen (16) families;**
3. **Fifty-Five (55) individuals;**

WHEREAS, the **Social Service Department (SSD)** of the City of Muntinlupa and the **Barangay Chairman of Bayanan**, conducted a survey on the victims of the fire to determine the homeowners, renters and sharers, basing the category of victims in accordance with prevailing ordinances, a recommendation on the matter that would entail a total amount of **Eighty Thousand Pesos (Php80,000.00)** financial assistance to be distributed as follows:

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the **10th Sangguniang Panlungsod**, to grant the total amount of **Eighty Thousand Pesos (Php80,000.00)** of Financial Assistance to the sixteen (16) Families affected by fire on **August 1, 2023** at **No. 127 & 178, Bautista St., Purok 3, Barangay Bayanan, Muntinlupa City**.

ENACTED FURTHER, that the **Final Disaster Report** dated **August 1, 2023**, of the **Social Services Department (SSD)** shall be charge to the **70% Quick Response Fund (QRF)** from the **Department of Disaster Resilience and Management (DDRM)** with **AIP Reference 1000-001-2-921-150-005-001** and **Account Code** of Other MOOE: **5-02-99-990**, shall form part of this ordinance.

ENACTED, by the **10th Sangguniang Panlungsod of Muntinlupa** this **14th day of August 2023**, on its **58th Regular Session**.




