WHEREAS, Article 99, 2(i) of the implementing Rules and Regulations of the LGC, states that the Sanggunian Panlungsod, "Shall approve the annual and supplemental budgets of the City government and appropriate funds for specific programs, projects, services, and activities of the city, or for other purposes not contrary to law, in order to promote the general welfare of the city and its inhabitants":

WHEREAS, Sections 312 and 319 of the LGC and Article 417 of its implementing Rules and Regulations (LGC-IRR), as amended by Administrative Officer (A.O.) No. 47 series of 1993, "Allow changes in the Annual Budget of the LGU through a supplement in the Annual Budget under specified circumstances and pursuant to the requirements of the LGC and other applicable laws, rules, and regulations";

WHEREAS, the Statement of Supplemental Appropriation for calendar year 2023 indicates that the Supplemental Budget No.2 will be utilized for capital outlays and maintenance and other operating expenses for disaster prevention and mitigation, disaster preparedness, disaster response, and disaster recovery and rehabilitation;

WHEREAS, the Revised Annual Investment Program (AIP) to support the programs subject of the Supplemental Budget No. 2 was approved by the Sangguniang Panlungsod through Resolution No. 2023-313;

NOW THEREFORE, BE IT ENACTED, by the **10**th **Sangguniang Panlungsod** in a Session assembled that:

SECTION 1. The Supplemental Budget No. 2, Series of 2023 of the City Government of Muntinlupa for FY 2023 in the total amount of Three Hundred Seventy-Five Million Four Hundred Thirty-Nine Thousand One Hundred Sixty-Nine Pesos and Thirty-Eight Centavos (Php375,439,169.38), as approved in the Revised Annual Investment Program under Resolution No. 2023-313, is hereby approved.

SECTION 2. Source of Funds. The Unexpended Balance of Local Disaster Risk Reduction Management Fund (LDRRMF), in the amount of Three Hundred Seventy-Five Million Four Hundred Thirty-Nine Thousand One Hundred Sixty-Nine Pesos and Thirty-Eight Centavos (Php375,439,169.38) as certified by City Accountant and City Treasurer, as follows:
