**AN ORDINANCE GRANTING THE TOTAL AMOUNT OF FORTY THOUSAND PESOS (PHP40,000.00) OF FINANCIAL ASSISTANCE TO THE TWO (2) FAMILIES AFFECTED BY FIRE ON AUGUST 15, 2023 AT NO. 43, KENTUCKY DRIVE, ALABANG 400, BARANGAY CUPANG, MUNTINLUPA CITY**

**WHEREAS**, Section 16 of the Local Government Code of 1991 states that *“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*:

**WHEREAS**, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, *“The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx”*;

**WHEREAS**, on **August 15, 2023**, One (1) structure, housing two (2) families, were gutted by fire at **No. 43, Kentucky Drive, Alabang 400, Barangay Cupang, Muntinlupa City**;

**WHEREAS**, in a final report rendered by the **Social Services Department** on **August 18, 2023**, and received by the **SP Secretariat Office** on **August 29, 2023** the following were noted as casualties of the said fire:

1. **One (1) structure;**
2. **Two (2) families;**
3. **Ten (10) individuals;**

WHEREAS, the **Social Service Department (SSD)** of the City of Muntinlupa and the **Barangay Chairman of Cupang**, conducted a survey on the victims of the fire to determine the homeowners, renters and sharers, basing the category of victims in accordance with prevailing ordinances, a recommendation on the matter that would entail a total amount of **Forty Thousand Pesos (Php40,000.00)** financial assistance to be distributed as follows:

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the **10<sup>th</sup> Sangguniang Panlungsod**, to grant the total amount of **Forty Thousand Pesos (Php40,000.00)** of Financial Assistance to the two (2) Families affected by fire on **August 15, 2023** at **No. 43, Kentucky Drive, Alabang 400, Barangay Cupang, Muntinlupa City**.

ENACTED FURTHER, that the **Final Disaster Report** dated **August 18, 2023**, of the **Social Services Department (SSD)** shall be charge from the **70% of Department of Disaster Resilience and Management (DDRM) Fund** with **AIP Reference 1000-001-2-921-150-005-001** and **Account Code of Other MOOE: 5-02-99-990**, shall form part of this ordinance.

ENACTED, by the **10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa** this **4<sup>th</sup>** day of **September 2023**, on its **61<sup>st</sup> Regular Session**.






