BIAZON, TO ENTER INTO AN AMENDED MEMORANDUM OF AGREEMENT (MOA) WITH THE DOST-NCR REPRESENTED BY ITS UNDERSECRETARY FOR REGIONAL OPERATIONS, ON THE IMPLEMENTATION OF THE "PROJECT ONE THOUSAND (1,000) ROLL-OUT OF RXBOX 1000 TELEHEALTH DEVICES FOR MUNTINLUPA HEALTH CENTERS LOCATED IN POBLACION, TUNASAN AND SUCAT

WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, *"every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare"*;

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing the LGC (LGC-IRR), provides that, *"(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City, and in this connection, shall: Xxx (vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance."*;

WHEREAS, the Department of Science and Technology (DOST) has collaborated with the University of the Philippines National Telehealth Center (UP-NTHC) and the Department of Health (DOH) in the implementation of the project *"Roll-out of RX Box 1000 Telehealth Devices in selected Healthcare facilities in the Philippines"*;

WHEREAS, Rx Box is a biomedical device capable of measuring a patient's vital signs, such as temperature, blood pressure, heart rate, oxygen saturation, uterine contractions, and electrocardiogram readings. With its user-friendly interface and high-resolution display, patients can easily monitor their health and share this information with their healthcare provider, enabling prompt medical interventions and reducing the need for in-person visits;

WHEREAS, the City Government of Muntinlupa, by virtue of Sanggunian Resolution 2022-006, is a recipient of Rx Box 1000 Telehealth devices intended solely for Tunasan Health Center;

WHEREAS, foreseeing the benefit, efficiency and ease the RX Box may bring to the constituency and pursuant to the **7K Agenda under Kalusugan**, a revised MOA to include the Muntinlupa Health Centers such as **Sucat (Sucat Sports Complex, Barangay Sucat) Poblacion (Rizal Street, Barangay Poblacion)** and **Tunasan (Barangay Tunasan)** must be executed. The three health centers mentioned are mandated under the MOA to provide operational and administrative support in the implementation of the project;

WHEREAS, the RxBox set is on a Loan basis for Three (3) months and may be donated to the mentioned Health Centers;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **10th Sangguniang Panlungsod of Muntinlupa**, to authorize the **Hon. City Mayor Rozzano Rufino B. Biazon**, to enter into an amended **Memorandum of Agreement (MOA)** with the DOST-NCR represented by its Undersecretary for Regional Operations, on the implementation of the **"Project Roll-Out Of One Thousand (1,000) RxBox Telehealth Devices** For Muntinlupa Health Centers Located at Poblacion, Tunasan and Sucat.

ADOPTED, by the **10th Sangguniang Panlungsod of Muntinlupa** this **7th** day of **August 2023**, on its **57th Regular Session**.
