BIAZON, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA (CGM) TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH EUROLINK NETWORK INTERNATIONAL CORPORATION (EUROLINK) FOR THE LATTER'S ENGAGEMENT AS THE EXCLUSIVE eCLAIMS HEALTH INFORMATION TECHNOLOGY PROVIDER (HITP) IN THE BENEFIT CLAIMS TRANSACTIONS FOR PHILHEALTH FOR THE CGM'S OUTPATIENT TB DOTS PHILHEALTH PACKAGE.

WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, **"every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;**

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations implementing the LGC (LGC-IRR), provides that, **"(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City, and in this connection, shall: Xxx (vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance."**

WHEREAS, by virtue of Philhealth Circular No. 14-2011, Eurolink Network International Corporation (**Eurolink**) was officially accredited Philhealth's Health Information Technology Provider;

WHEREAS, the City Government of Muntinlupa (CGM) for the past 10 years has entered into a Memoranda of Agreement with Eurolink for the various packages being implemented by the Philippine Health Insurance Corporation (PHILHEALTH) which includes: claims for Outpatient HIV/Aids Treatment Package and TB-DOTS package;

WHEREAS, Fifteen (15) Health Centers in Muntinlupa has been using the Eurolink System and the terms of its use is about to expire, hence a renewal of the MOA should be executed;

WHEREAS, the MOA subject of renewal, departs from the previous ones entered into by the CGM notably on pre-termination fee, term of the contract and the designated venue in case of conflict. The modifications mentioned hereto were reviewed by the City Legal Office which rendered a favourable opinion for the renewal of the MOA;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to authorize the **City Mayor Hon. Rozzano Rufino B. Biazon**, in behalf of the City Government of Muntinlupa (CGM) to enter into a Memorandum of Agreement (MOA) with Eurolink Network International Corporation (EUROLINK) for the latter's engagement as the exclusive eClaims Health Information Technology Provider (HITP) in the benefit claims transactions for PHILHEALTH for the CGM'S Outpatient TB DOTS Philhealth Package.

ADOPTED, by the 10th **Sangguniang Panlungsod of Muntinlupa** this 7th day of **August 2023**, on its 57th **Regular Session**.


