**WHEREAS, Sec 16 of the 1987 Constitution provides that, "The State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature;"**

**WHEREAS, SECTION 35 of Republic Act No. 7160, otherwise known as the Local Government Code (LGC) of 1991 provides, "Local government units may enter into joint ventures and such other cooperative arrangements with people's and nongovernmental organizations to engage in the delivery of certain basic services, capability-building and livelihood projects, and to develop local enterprises designed to improve productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance, and enhance the economic and social well-being of the people"**

**WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing the LGC of 1991, provides that "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) Represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";**

**WHEREAS**, Rule IX, Article 47(a), supra, **“Unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.”**;

**WHEREAS**, Kabang Kalikasan ng Pilipinas Foundation, Inc., (KKPFI) a national organization of the World Wide Fund (WWF) for Nature which conservation program places strong emphasis on the conservation of marine species and habitats and utilizes highly integrative and participatory approaches to find solutions that work for the environment and for the people that live and depend on it;

**WHEREAS**, one of KKPFI advocacies is the One Planet City Challenge (OPCC), which aims to recognize cities that are leading the transition towards a climate-resilient, one planet future. Launched in 2011 as the Earth Hour City Challenge (EHCC), OPCC is a biennial, global challenge for cities to present ambitious, holistic, inspiring and credible plans for low carbon;

**WHEREAS**, the CGM, an active participant of the OPCC and is declared as one of the national finalists in the Philippines, would again join the program and shall undergo assessment on the following areas: greenhouse gas emissions and risks from climate change; mitigation targets and adaptation goals; climate action plan and implementation of strategies and or actions and; result based monitoring;

**WHEREAS**, the data and information collected shall be reported to and collected by the KKPFI. The terms for the use and collection of data, the subject of the MOU, was reviewed by the City Legal Office which rendered no adverse opinion;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the City Mayor Hon. Rozzano Rufino B. Biazon to enter into a Memorandum of Understanding (MOU) with Kabang Kalikasan ng Pilipinas Foundation, Inc., (KKPFI) represented by Katherine Custodio, Executive Director, on the implementation of the Planet City Challenge.
