WHEREAS, Sec 16 of the 1987 Constitution provides that, "The State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature;"

WHEREAS, SECTION 35 of Republic Act No. 7160, otherwise known as the Local Government Code (LGC) of 1991 provides, "Local government units may enter into joint ventures and such other cooperative arrangements with people's and nongovernmental organizations to engage in the delivery of certain basic services, capability-building and livelihood projects, and to develop local enterprises designed to improve productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance, and enhance the economic and social well-being of the people"

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall:

> (1) Exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) Represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";

WHEREAS, Rule IX, Article 47(a), Supra, provides that, "Unless otherwise) provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.";

WHEREAS, pursuant to E.O. 192 series of 1987 the Department Of Environment And Natural Resources (DENR) is mandated to formulate, implement, and supervise the government's policies, plans and programs pertaining to the management, conservation, development, use and replenishment of the country's natural resources;

WHEREAS, the DENR through its Environment Management Bureau -NCR, pursuant to the Clean Air Act, has collaborated with the Filinvest Alabang Inc. (FAI) and the City Government of Muntinlupa (CGM) to set up a Continuous Ambient Air Monitoring System (CAAMS) equipment to be installed at South Station Terminal for air quality monitoring;

WHEREAS, the rights and obligations of the parties were laid out in the Memorandum of Agreement reviewed by the City Legal Office which interposed no objection to the proposed MOA, citing "safe and clean air is consistent with the City's 7K Agenda as well as with the right of the people to breath clean air and to be informed of the level of air pollution under R.A 8749, Section 36 of the said law mandates LGUs to share in the responsibility of managing and maintaining air quality within its territorial jurisdiction;"

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to authorize the City Mayor Hon. Rozzano Rufino B. Biazon to enter into a Tripartite Memorandum of Agreement (MOA) Department of Environment and Natural Resources-Environmental Management Bureau, National Capital Region (DENR-EMB,NCR) represented by Regional Director Atty. Michael Drake P. Matias and Filinvest Alabang, Inc., represented by First Vice President for Project Development-Townships for the operation of the Continuous Ambient Air Monitoring System (CAAMS) equipment to be installed at South Station Terminal, Alabang, Muntinlupa.
