BIAZON, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA (CGM) TO ENTER AND SIGN THE CONTRACT OF SERVICE WITH BP INTEGRATED TECHNOLOGIES, INC., REPRESENTED BY GIAN CARLO B. DIZON TECHNICAL SALES ENGINEER, ON THE PROVISION OF ANNUAL DATA HOSTING SERVICES FOR THE CITY GOVERNMENT OF MUNTINLUPA WEB DISPLAY, CLOUDCONN AND MOBILE APPLICATION IN THE AMOUNT OF SIX HUNDRED FIFTY EIGHT THOUSAND SIX HUNDRED FORTY-SIX PESOS AND 52/100 (PHP658,646.52) AND SHALL BE TAKEN FROM THE 2023 EXECUTIVE BUDGET UNDER THE DEPARTMENT OF DISASTER RESILIENCE AND MANAGEMENT (DDRM)

WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, "every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations implementing the LGC (LGC-|RR), provides that, "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";

WHEREAS, under Section 53 of Republic Act No. 9184 and in relation to Section 53.9 of the Revised Implementing Rules and Regulations of said law, Negotiated Alternative of Procurement (thru Small Value Procurement) may be resorted to in the procurement of goods, infrastructure projects and consulting services, whereby the procuring entity may directly negotiate a contract with a technically, legal and financially capable supplier, contractor or consultant";

WHEREAS, where the procurement does not fall under Shopping as set forth in Section 52 of R.A 9184 and its IRR and the amount involved **does not exceed One Million Pesos (Php1,000,000.00)**, the procuring entity may avail the **Negotiated Alternative Mode of Procurement** by drawing up a list of at least three (3) suppliers, in the case of goods and infrastructure projects;

WHEREAS, BP Integrated Technologies, Inc., is a corporation which provides Data Hosting Services for the **Department of Disaster Resilience and Management** (DDRM), storing among others the City Government of Muntinlupa's (CGM) web display, cloudconn and mobile application;

WHEREAS, the contract with BP Integrated technologies, Inc has lapsed and there is a need to enter into another contract of services in the amount of Six Hundred Fifty-Eight Thousand Six Hundred Forty-Six Pesos and 52/100 (Php658,646.52) for the contract period July 1, 2023 up to June 30, 2024;

WHEREAS, there is an available fund from the 2023 Executive Budget under the DDRM;

WHEREAS, the City Legal Office rendered a favorable opinion and recommended that the Data Privacy Act coverage shall include subcontractors, agents and personnel;

NOW, THEREFORE BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to authorize a resolution authorizing the *City Mayor Hon. Rozzano Rufino B. Biazon*, in behalf of the City Government of Muntinlupa (CGM) to enter and sign the Contract of Service with *BP Integrated Technologies, Inc.*, represented by *Gian Carlo B. Dizon Technical Sales Engineer*, on the provision of Annual Data Hosting services for the City Government of Muntinlupa's Web display, cloudconn and mobile application amounting to Six Hundred Fifty Eight Thousand Six Hundred Forty-Six Pesos and 52/100 (Php658,646.52) and shall be taken from the 2023 Executive Budget under the *Department of Disaster Resilience and Management (DDRM)*

ADOPTED, by the 10th Sangguniang Panlungsod of Muntinlupa this 7th day of August 2023, on its 57th Regular Session.


