WHEREAS, Section 10, Article X of the 1987 Philippine Constitution states that, *"The State shall give priority to xxx science and technology education, training, and services. It shall support indigenous, appropriate, and self-reliant scientific and technological capabilities, and their application to the country's productive systems and national life;"*

WHEREAS, Section 12, *supra*, provides that, *"The State shall xxx encourage the widest participation of private groups, local governments, and community-based organizations in the generation and utilization of science and technology;"*

WHEREAS, Section 5 of Republic Act No. 10844 or *An Act Creating The Department Of Information And Communications Technology, Defining Its Powers And Functions Appropriating Funds Therefor, And For Other Purposes*, mandated the DICT to be *"the primary policy, planning, coordinating, implementing, and administrative entity of the Executive Branch of the government that will plan, develop, and promote the national ICT development agenda;"*

WHEREAS, Section 2 of Republic Act No. 11032, also known as **An Act Promoting Ease Of Doing Business And Efficient Delivery Of Government Services, Amending For The Purpose Republic Act No. 9485, Otherwise Known As The Anti-Red Tape Act Of 2007**, provides that *"It is hereby declared the policy of the State to promote integrity, accountability, proper management of public affairs and public property as well as to establish effective practices, aimed at efficient turnaround of the delivery of government services and the prevention of graft and corruption in government. Towards this end, the State shall maintain honesty and responsibility among its public officials and employees, and shall take appropriate measures to promote transparency in each agency with regard to the manner of transacting with the public, which shall encompass a program for the adoption of simplified requirements and procedures that will reduce red tape and expedite business and nonbusiness related transactions in government;"*

WHEREAS, Section 2 of Republic Act No. 11055 also known as **An Act Establishing The Philippine Identification System** states that, *"To promote seamless delivery of service, to improve the efficiency, transparency, and targeted delivery of public and social services, to enhance administrative governance to reduce corruption and curtail bureaucratic red tape, to avert fraudulent transactions and misrepresentations, to strengthen financial inclusion, and to promote ease of doing business;"*

WHEREAS, in line with the President's commitment to improve bureaucratic efficiency by capitalizing on digitization efforts, the President issued Executive Order No. 29, Series of 2023 which provides that, *"All departments, agencies, and instrumentalities of the National Government, including government-owned or -controlled corporations (GOCCs), are hereby directed, and all local government units are hereby encouraged, to adopt, and implement the Integrated Financial Management Information System (IFMIS) in the processing of government financial transactions consistent with Section 4 this Executive Order";*

WHEREAS, consistent to the above-mentioned laws and issuances, the **Department of Information and Communications Technology (DICT)** posited the "eGov PH", also known as the e-Government Philippines (e-GovPH), which is a **mobile application** that simplifies transactions between the government and citizens which integrates the multi-sectoral government through a one-stop online system that will minimize economic cost for the citizens;

WHEREAS, the e-Gov PH uses a comprehensive platform through e-GovPH Super App, which was launched in June 2023, with the aim to digitize and streamline national and local government services such as the digitization of government-issued IDs like the National ID and driver's license, integration of outbound and inbound travel declaration forms, business registration, tax payment, and social security benefits;
