**WHEREAS**, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, *“Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;*

**WHEREAS**, Article 86(b)(1)(vi) of the Rules and Regulations implementing the LGC (LGC-IRR), provides that, *“(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City;*

**WHEREAS**, an academic affiliation is being proposed by the two departments under the Executive Office of the City Government of Muntinlupa, under which the level 3 Ospital ng Muntinlupa and the TESDA-recognized Muntinlupa City Technical Institute (MCTI) will be parties to a written agreement for the former to accept and train the care-giving students of the latter;

**WHEREAS**, the Contract of Affiliation, with a term of one (1) year, is limited only to one (1) on the job (OJT) /intern per nursing station and one OJT/Intern at the Out-Patient Department;
