WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, "Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, pursuant to Article 99, 2(i) of the LGC Implementing Rules and Regulations, the Sangguniang Panlungsod, "Shall approve the annual and supplemental budgets of the City government and appropriated funds for specific programs, projects, services and activities of the city, or for other purposes not contrary to law in order to promote the general welfare of the City and its inhabitants";

WHEREAS, on August 2023, the City Development Council (CDC) pursuant to its mandate to appraise and prioritize socioeconomic development programs and projects of the local government unit, adopted its Resolution No. 02 Series of 2023 also known as A Resolution Adopting The Supplemental Annual Investment Program (AIP) And Its Supplemental Budget For Fiscal Year 2023;



WHEREAS, the Supplemental AIP No. 2 setforth the various programs and projects to be implemented by the Department of Disaster Resilience and Management Office (DDRMO) which will be funded from the 2022 Unexpended Continuing Appropriation under the General Fund estimated to be worth Five Hundred Fourteen Million Seven Hundred Ninety-Three Thousand Six Hundred Nineteen Pesos and Sixty-six Centavos (Php 514,793,619.66);

WHEREAS, a portion of the 2022 Unexpended Continuing Appropriation, duly certified correct by the City Treasurer and Local Accountant, or Three Hundred Seventy Five Million Four Hundred Thirty Nine Thousand One Hundred Sixty Nine Pesos and Thirty Eight Centavos (Php365,439,169.38) will be utilized for the purchase of capital outlays for disaster prevention and mitigation disaster preparedness, disaster response, and disaster recovery and rehabilitation;

WHEREAS, the Consolidated Supplemental AIP No. 2 as of July 27, 2023, as required by law, was approved by the Local Disaster Risk Reduction and Management Council (LDRRMC) through its Resolutions No. 3 and 4 series of 2023;

NOW THEREFORE, BE IT ENACTED, AS IT IS HEREBY RESOLVED, by 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to adopt City Development Council (CDC) Resolution No. 2 S. 2023 otherwise known as, A Resolution Adopting The Supplemental Annual Investment Program (AIP) And Its Supplemental Budget For Fiscal Year 2023

**RESOLVED FURTHER**, that a copy of this resolution be given to the **Department** of **Budget and Management** (**DBM**) and other concerned offices for their information and appropriate review
