WHEREAS, Section 455 (b)(1)9(vi) of the Local Government Code provides that, "the City Mayor shall exercise such powers and performs functions for efficient, effective and economical governance the purpose of which is the general welfare of its inhabitants pursuant to Sec 16 of RA7160, the city mayor shall represent the city in all business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod";

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing the Local Government Code of 1991 provides that, ***“Unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.”***;

WHEREAS, Section 35 of LGC of 1991, provides that, ***“Local government units may enter into joint ventures and such other cooperative arrangements with people's and nongovernmental organizations to engage in the delivery of certain basic services, capability-building and livelihood projects, and to develop local enterprises designed to improve productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance, and enhance the economic and social well-being of the people.”***;

WHEREAS, Technical Education And Skills Development Authority (TESDA) Memorandum Circular No. 107 Series of 2021 also known as the **Omnibus Guidelines on Technical Vocational Education and Training (TVET) Program Registration** empowers TESDA to establish and maintain a system of accrediting, coordinating, integrating, monitoring and evaluating formal and non-formal NET programs provides for the **Supervised Industry Learning (SIL)** designed to complement the training gained in the institution with the intention of enhancing the knowledge and skills of a Learner through actual application of the core competencies in the workplace, as identified in the Training Regulations;

WHEREAS, the City Government of Muntinlupa (CGM), through its Muntinlupa City Technical Institute (MCTI), supports the implementation of Republic Act No. 7796 or the TESDA Act of 1994, where local government units shall assume the responsibility for effectively providing community-based technical education and skills development opportunities;

WHEREAS, the DSWD as the primary social welfare and development agency of the Philippine Government is mandate to provide social protection and promote the rights and welfare of the poor, vulnerable, disadvantage children, youth, women, older persons, person with disabilities, family in crisis or at risk and communities to contribute to poverty alleviation, and empowerment to through social welfare development policies and programs, services and projects;

WHEREAS, pursuant thereto, the CGM enters into a Memorandum of Agreement for SIL with the **Department Of Social Welfare And Development-National Capital Region, Elsie Gaches Village (Dswd-Ncr, Egv) Represented By Regional Director Monina Josefina H. Romualdez**, to establish a program where MCTI will provide skills development training to the residents and staff of the **Elsie Gaches Village** operated by DSWD-NCR;

WHEREAS, the program will provide the residents of Elsie Gaches Village with needed development skills and training;

WHEREAS, to further improve the service and program implementation of DSWD-NCR, EGV, the involvement and support of MCTI is necessary.
