WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, **"Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;**

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations implementing the LGC (LGC-IRR), provides that, **"(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City;**

WHEREAS, an affiliation agreement is being forged between the **CGM** and **Southville International School and College** for purposes of providing an educational opportunity for the latter's nursing students in a supervisory situation such as clinical experience in the former's Lying-in Clinics;

WHEREAS, the CGM has one Lying-in clinic located at Barangay Putatan which offers pre natal care, delivery, post partum care, new born and family planning services. Such services are the areas of clinical experience needed by the nursing students where the students may gain practical knowledge;

WHEREAS, the COAf will benefit more or less twelve nursing students per shift, whose on- the –site training is subject to the policies procedures and guidelines governing the training and affiliation of students laid down by the Department of Health and the Commission of Higher Education;

WHEREAS, the CGM, pursuant to its 7K agenda, shall provide maximum opportunity for students to gain experience, allow them to experience training with supervision and assist in their supplemental education, training and development upon submission of the certified list of interns and other documents and payment of affiliation fees:

- i. 6 hours = Php63.625/student within the given semester
- ii. 8 hours = Php85.00/student within the given semester

The affiliation fees shall be properly acknowledged with official receipts from the City Treasurer's Office and be held in a Trust fund for the maintenance and operating expenses of the Lying-In Clinic.

WHEREAS, the duration of the Contract shall be for one (1) year and may be renewed upon mutual agreement of parties;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to authorize the **City Mayor Rozzano Rufino B. Biazon** in behalf of the City Government of Muntinlupa (CGM) to enter and sign the **Contract Of Affiliation (CoAf)** with **Southville International School and College** for the **Training of the latter's Nursing Students at the Former's Lying-In Clinics.**




