THIS AGREEMENT made the 2 8 2023 20_____ between CITY GOVERNMENT day of OF MUNTINLUPA of the Philippines (hereinafter called "the Entity") of the one part and A.T. FOURTEEN INT'L. CO. with address at Biñan Laguna (hereinafter called "the Supplier") of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the Supply & Delivery of Nutri Packs & Whole Grain Rice for 350 Malnourished Children in 8 Barangays and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Two Million Six Hundred Sixty Five Thousand Three Hundred Twenty Pesos (P2,665,320.00)(hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
