## Contract Agreement

THIS AGREEMENT, made this \_\_\_\_\_ day of \_\_\_\_\_\_\_, 2023 between CITY GOVERNMENT OF MUNTINLUPA with address at City Hall, National Road, Putatan, Muntinlupa City, (hereinafter called the "Entity") and EIKONIC BUILDERS INC. with address at Sucat, Parañaque City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **Rehabilitation of Water Supply System at Pacwood Tunasan, Muntinlupa City/10051702** (hereinafter called "the Works") and the Entity has accepted the Bid for **Nine Million Eight Hundred Thirty Two Thousand Pesos (P9,832,000.00)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.</u>

- In consideration for the sum of Nine Million Eight Hundred Thirty Two Thousand Pesos (P9,832,000.00) or such other sums as may be ascertained, EIKONIC BUILDERS INC. agrees to the Rehabilitation of Water Supply System at Pacwood Tunasan, Muntinlupa City in accordance with his/her/its Bid.
