Contract Agreement

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the Supply & Delivery of Food Relief for Stockpiling & Prepositioning Disaster Affected Families in Muntinlupa and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Two Million One Hundred Fifty Three Thousand Two Hundred Twenty Five Pesos (P2,153,225.00) (hereinafter called "the Contract Price").


