### Contract Agreement

THIS AGREEMENT made the \_\_\_\_\_ day of \_\_\_\_DEC 1 2020 between CITY GOVERNMENT OF MUNTINLUPA of the Philippines (hereinafter called "the Entity") of the one part and M.R. BELARMA ENTERPRISES with address at Muntinlupa City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the Supply & Delivery of Grocery Items to be given to Constituents of Muntinlupa and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Two Million Eight Hundred Eighty Four Thousand Eighty Seven Pesos (P2,884,087.00)(hereinafter called "the Contract Price").


