A RESOLUTION AUTHORIZING THE CITY MAYOR ATTY. JAIME R. FRESNEDI TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE OFFICE OF THE CIVIL DEFENSE (OCD) NATIONAL CAPITAL REGION (NCR) REPRESENTED BY ROMULO M. CABANTAG, JR. ON THE PROVISION OF FROZEN FISH INTENDED TO AUGMENT THE RELIEF ASSISTANCE EXTENDED TO NEEDY FAMILIES IN NCR DUE TO COVID -19

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that **“(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.”;**

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, **“unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.”;**

WHEREAS, the **Office of Civil Defense (OCD)** a government entity with Office Address at 81 RBA Building, 15th Avenue, Murphy Cupac, Quezon City represented herein by its OCD Regional Director, Romulo M. Cabantag, Jr.;

WHEREAS, Administrative Order No. 27, establishing a framework for the acceptance, management, distribution and delivery of all medicines, medical equipment and supplies, and other health products donated to the Nation, provides that, **“all donations to the National Government which include among others, health products intended to address the Covid-19 situation, whether received or accepted from foreign governments, private entities, non-governmental organizations, or any group or individual, shall be coordinated with and transmitted to the Office of the Civil Defense (OCD) for consolidation, distribution and delivery of the donated health products to identified beneficiary facilities, groups or establishments”**;

WHEREAS, OCD received a donation from the **Bureau of Customs (BoC)** consisting of frozen fish intended to augment the relief assistance extended to Local Government Units (LGUs) in the NCR due to Covid-19 and through coordinated efforts from the national government agencies such as the **Department of Social Welfare and Development (DSWD, the Department of Agriculture (DA), and the Philippine National Police (PNP)**, the City of Muntinlupa shall be a recipient of the said frozen fish;

WHEREAS, the terms for the acceptance, delivery, disposition and reportorial requirements on the donated frozen fish are embodied in a Memorandum of Agreement (MOA) to which the City Legal Office interposed no objection;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa, to authorize the **City Mayor Atty. Jaime R. Fresnedi** to enter into a **Memorandum of Agreement (MOA)** with the **Office of the Civil Defense (OCD) National Capital Region (NCR)** represented by **Romulo M. Cabantag, Jr.** on the provision of frozen fish intended to augment the relief assistance extended to needy families in NCR due to Covid -19

FINALLY RESOLVED, that copy of this approved Resolution be given to the Office of Civil Defense (OCD), City Social Services Department (CSSD), Philippine National Police (PNP), Office of Bureau of Custom (BoC), Department of Social Welfare and Development (DSWD) and Department of Agriculture (DA).

ADOPTED, by the 9th **Sangguniang Panlungsod of Muntinlupa** this 1st day of February, 2021, on its 82nd Regular Session.
