WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project **Interior Works Environment Protection and Natural Resources Office (EPNRO)** located at **Annex Building, City Hall, Barangay Putatan, Muntinlupa City** in the newspaper of general circulation and likewise posted at the Government Electronic Procurement System (GEPS), and City's Website and conspicuous places at the premises of the City Government of Muntinlupa continuously for seven (7) days,




