WHEREAS, Section 455 of Republic Act 7160, otherwise known as the Local Government Code, "empowers the city mayor, as chief executive of the city government, to exercise such powers and perform such duties and functions for efficient, effective and economical governance the purpose of which is the general welfare of the city and its inhabitants to exercise general supervision and control over all programs, projects, services, and activities of the city government, and in this connection, shall: (vi) Represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance";

WHEREAS, various health protocols and community quarantines were implemented when on 30 January 2020, the World Health Organization (WHO) declared Coronavirus Disease 2019 (COVID-19), as a Public Health Emergency of international Concern (PHEIC);

WHEREAS, the CHRMD proposed an alternative means to monitor the attendance of the City employees and personnel, adopting the **Facial Recognition System** as against the present biometrics systems to avoid physical contact with the machines which may be a source in the spread of the disease;

WHEREAS, the SPIDC, with office address at No. 4 PSP Avenue, Metroville Cainta Rizal, is presently the provider of the local version of the PMIPS and in the better position to develop and upgrade the biometrics using the Facial Recognition System and Web-based PMIPS;

WHEREAS, the Subscription Agreement (SA) with SPIDC includes the following on site services: technical support staff; training and workshop; software and database technology installation; software engineering services; call, SMS, mobile and remote access servicing; system integration services to other subscriber owned software, hardware and or system and; management and technology consulting services;

WHEREAS, the City Legal Office interposed no objections to the terms and provisions in the service agreement save for the suggestion to lessen the lock in period of the contract;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, By The 9th Sangguniang Panlungsod, to authorize the **City Mayor Atty. Jaime R. Fresnedi** in behalf of the City of Muntinlupa to enter into a Subscription Agreement (SA) with **Systems and Plan Integrator and Development Corporation (SPIDC)** represented by its Chief Executive Officer **Engr. Julieta M. Cunanan** for the enhancement of the **Personnel Management Information and Payroll System (PMIPS)** in the City Human Resource Management Department (CHRMD).
