WHEREAS, the Contract of Security Service was signed by both parties and duly notarized on January 15, 2021;

WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the provision of **Security & Protection Services** for the **Ospital ng Muntinlupa** located at **Civic Drive, Filinvest Corporate City, Barangay Alabang, Muntinlupa City** in the newspaper of general circulation and likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisement, one (1) bidder submitted letter of intent and application for eligibility and was found eligible on **December 15, 2020**;

WHEREAS, on **December 15, 2020**, the **Joint Venture of Best Security Agency, Inc. and Best Arms Security's** bid passed the Preliminary Examination of Bid at the City Administration Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan. Muntinlupa;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **Joint Venture of Best Security Agency, Inc. and Best Arms Security's** bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to **Ten Million Seven Hundred Fifty-Eight Thousand Six Hundred Forty-Nine Pesos (Php10,758,649.00)**;

WHEREAS, the contract was awarded to **Joint Venture of Best Security Agency, Inc. and Best Arms Security**, who being the lone bidder for the provision of Security and Protection Services;

WHEREAS, there is an appropriated budget from the 2021 Executive Budget under the abovementioned Department;

WHEREAS, the **City Legal Office (CLO)** interposes no objection to the Contract Security Services since it went thru the bidding process conducted by the BAC Office and in accordance with Republic Act No. 9184 or the General Procurement Act;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th **Sangguniang Panlungsod**, to ratify the Contract of Security Services entered into and signed by the **City Mayor Hon. Atty. Jaime R. Fresnedi**, in behalf of the **Ospital ng Muntinlupa (OSMUN)** with Joint Venture of **Best Security Agency, Inc. & Best Arms Security** for the provision of security and protection services on the premises of **Ospital ng Muntinlupa (OSMUN)** located in **Civic Drive, Filinvest Corporate City, Barangay Alabang, Muntinlupa City** amounting to **Ten Million Six Hundred Forty-Four Thousand Four Hundred Sixty Six Pesos And 80/100 (Php10,644,466.80)** which amount shall be taken from the 2021 Executive Budget.
