WHEARES, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, *Mahalimuyak Laundry Corporation's* bid has been responsive to Approved Budget for the Contract (ABC) amounting to Two Million Two Hundred Five Thousand Pesos (Php2,205,000.00);

WHEREAS, the contract was awarded to Mahalimuyak Laundry Corporation, who being the lone bidder for the *laundry services*;

**WHEREAS,** there is an appropriated budget from the 2021 Executive Budget under the abovementioned Department;
