WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the **Arterial Blood Gas Machine** at the **Ospital ng Muntinlupa** located at **Civic Drive, Filinvest Corporate City, Barangay Alabang, Muntinlupa City** in the newspaper of general circulation and likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisement, two (2) bidders submitted letter of intent and application for eligibility and was found eligible on **December 15, 2020**;

WHEREAS, on **December 15, 2020**, the **Biosite Medical Instruments's** bid passed the Preliminary Examination of Bid at the City Administration Conference Room, 2<sup>nd</sup> Floor City Hall Main Building, National Road, Barangay Putatan. Muntinlupa;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **Biosite Medical Instrument's** bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to **Two Million One Hundred Thousand Pesos (Php2,100,000.00)**;

WHEREAS, the contract was awarded to **Biosite Medical Instruments** who being the winning bidder for the **Arterial Blood Gas Reagent Tie-Up**;

WHEREAS, there is an appropriated budget from the 2021 Executive Budget under the abovementioned Department;

WHEREAS, the **City Legal Office (CLO)** interposes no objection to the Contract of Services since it went thru the bidding process conducted by the BAC Office and in accordance with Republic Act No. 9184 or the General Procurement Act;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9<sup>th</sup> **Sangguniang Panlungsod**, to ratify the Contract of Services entered into and signed by the **City Mayor Hon. Atty. Jaime R. Fresnedi**, in behalf of the Ospital ng Muntinlupa (OSMUN) with **Biosite Medical Instruments** for the supply and delivery of **Arterial Blood Gas Machine Re-Agent** at the Ospital ng Muntinlupa located in Civic Drive, Filinvest Corporate City, Barangay Alabang, Muntinlupa City amounting to **One Million Six Hundred Twenty Thousand Pesos (Php1,620,000.00)** which amount shall be taken from the 2021 Executive Budget
