A RESOLUTION AUTHORIZING THE CITY MAYOR ATTY. JAIME R. FRESNEDI TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE STATISTIC AUTHORITY (PSA) ON THE IMPLEMENTATION OF THE PHILIPPINE IDENTIFICATION SYSTEM (PHILSYS) THE SINGLE NATIONAL SYSTEM FOR THE REGISTRATION OF ALL FILIPINOS AND RESIDENT ALIENS, IN THE CITY OF MUNTINLUPA

WHEREAS, Republic Act No. 11055, otherwise known as the “*Philippine Identification System Act*” was signed into law by President Rodrigo Roa Duterte on 06 August 2018 whereby the Philippine Statistics Authority (PSA) is mandated to be the implementing agency of the PhilSys and the creation of the PhilSys Policy and Coordination Council (PSPCC) to formulate policies and guidelines to ensure effective implementation of the PhilSys;

WHEREAS, the PhilSys shall primarily be established to provide a valid proof of identity for all citizens and resident aliens as a means of simplifying public and private transactions aimed to eliminate the need to present other forms of identification when transacting with the government and the private transactions;

WHEREAS, as implementing arm of the Philsys, the Philippine Statistics Authority (PSA) is tasked to carry out the overall planning, management and administration of the PhilSys including the collaboration with LGUs, other government agencies, and GOCCs in order to ensure the registration and enrolment of all citizens and resident aliens into the PhilSys including the indigenous cultural communities/indigenous people (ICCs/IPs) and those located in remote localities;

WHEREAS, the PSA is a government agency established by virtue of Republic Act No. 10625 or the Philippine Statistical Act of 2013;

WHEREAS, the Local Government Code of 1991 (RA 7160) provides that, **“national agencies and offices with project implementation functions shall coordinate with one another and with the local government units concerned in the discharge of these functions. They shall ensure the participation of local government units both in the planning and implementation of said national projects”**;

WHEREAS, Section 455 (b)(1)(vi) of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, **“the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance”**;

WHEREAS, under a delegated authority, the Regional Office of the PSA endeavors to enter into a Memorandum of Agreement with the City Government of Muntinlupa (CGM) whereby CGM is obligated to provide logistical and mobilization requirements, information dissemination of the Philsys and security of the health and safety of PSA personnel during the process of registration;

WHEREAS, the information that will be gathered during the registration activities shall be subject to the provisions of Republic Act No. 10173 otherwise known as the Data Privacy Act (DPA), its Implementing Rules, and Regulations;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod of Muntinlupa, to authorize the **City Mayor Atty. Jaime R. Fresnedi** to enter into a **Memorandum of Agreement (MOA)** with the **Philippine Statistic Authority (PSA)** on the implementation of the **Philippine Identification System (PhilSys)** the Single National System for the registration of all Filipinos and resident aliens, in the City of Muntinlupa.

ADOPTED, by the **9th Sangguniang Panlungsod of Muntinlupa** this **15th** day of **March, 2021**, on its **88th** Regular Session.






