**WHEREAS**, Republic Act No. 10066 otherwise known as the "National Cultural Heritage Act of 2009", mandates that, *"all cultural properties of the country deemed important to cultural heritage shall be registered in the Philippine Registry of Cultural Property (Registry) and empowered National Commission for Culture and the Arts (NCCA), through the appropriate cultural agencies and local government units, to establish and maintain the Registry within three (3) years from the effectivity of the law"*;

**WHEREAS**, the local government units, through their cultural offices, are likewise mandated, *"to maintain an inventory of cultural property under its jurisdiction and furnish the NCCA a copy of the guidelines in the registration of their respective cultural properties"*;

**WHEREAS**, Section 455 (b)(1)(vi) of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, *"the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance"*;

**WHEREAS**, the Tourism, Culture and the Arts Department (TCAD), created under Ordinance 18-194 is guided by ITS vision to make Muntinlupa one of the country's premier tourist destination that showcases a combination of traditional and contemporary Philippine Culture and the Arts;

**WHEREAS**, pursuant to Section 2, of Ordinance 18-194, TCAD's mission to identify historical and significant landmarks/sites, and other cultural heritage in the city and make effort to enrich, preserve, and protect them, "Project Cultural Heritage Mapping of Muntinlupa City (PROJECT) is conceived;

**WHEREAS**, the PROJECT has two components: cultural inventory and capacity-building or training, wherein, to establish baseline documentation and inter connectivity of cultural resources, collaboration with the **University of Sto. Tomas' (UST)** Center for Conservation of Cultural Property and Environment in the Tropics (CCCPET) is vital;

**WHEREAS**, UST is a globally recognized higher education institution that has the technical knowledge and expertise in conducting Cultural Heritage Mapping and offers assistance to many local government units in cultural conservation and preservation;

**WHEREAS**, the TCAD has appropriated and included in its Annual Investment Program (AIP) the amount of **Six Hundred Twenty Thousand Pesos (Php620,000.00)** for the PROGRAM as well as the cost of other expenses for its implementation;

**NOW THEREFORE BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the **9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa**, to authorize the City Mayor Atty. Jaime R. Fresnedi to represent Muntinlupa in a Memorandum of Agreement (MOA) and Understanding with the University of Sto. Tomas (UST) represented by **Reverend Father Isaias D. Tiongco, O.P.** on the implementation of the Cultural Heritage Mapping Project.
