WHEREAS, Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, **"the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance"**;

WHEREAS, Section 458 of RA 7160 mandates the Sangguniang Panlungsod, as the legislative body of the city, **"to enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants and in the proper exercise of the corporate powers of the city shall approve ordinances which shall ensure the efficient and effective delivery of the basic services and facilities, and in addition to said services and facilities, shall establish a scholarship fund for the poor but deserving students in schools located within its jurisdiction or for students residing within the city"**;

WHEREAS, in the year 2008, through **Ordinance No. 08-055**, the Muntinlupa Scholarship Program (MSP) was established to give financial assistance to students who are incapable to pay matriculation fees but are willing to pursue and finish their education, and from thereon, the MSP has evolved and is now dispensing scholarship assistance to more or less **Seventy-Two Thousand (72,000)** students;

WHEREAS, the pandemic of 2019 drastically changed the mode of interaction of people as the need to adhere to public health standards and quarantine protocols must be followed, thus, the MSP adopted an automated and contactless policy in order for it to pursue its mandate;

WHEREAS, on March 11, 2021, the **Local Finance Committee (LFC)** adopted **Resolution No. 06 Series of 2021** recommending the approval of the Financial Disbursement Service (FDS) with G-Xchange Inc. (GXl Phils/Gcash) as the disbursement service provider for the **Eight Thousand Five Hundred (8,500)** Senior High School Scholars for School Year 2020-2021;

WHEREAS, for the FDS, G-Xchange Inc. (GXl Phils/Gcash) shall charge the City Government of Muntinlupa and the payee a minimal fee depending on the transaction as provided in the FDS Agreement;

**NOW THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the **City Mayor Atty. Jaime R. Fresnedi** to represent Muntinlupa in a fund disbursement and Implementing Agreement with G-Xchange, Inc. represented by **Jose Luis G. Reyes** for Fund Disbursement Service (FDS) of the **Muntinlupa Scholarship Program (MSP)**.
