WHEREAS, Section 455 (b)(1)(vi) of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, **"the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance"**;

WHEREAS, Executive Order No. 128, approved on January 30, 1987, mandates the Department of Science and Technology (DOST) to **"provide central direction, leadership and coordination of scientific and technological efforts and ensure that the results therefrom are geared and utilized in areas of maximum economic and social benefits for the people"**;

WHEREAS, DOST implemented Community Empowerment through Science and Technology (CEST) program which is a package of Science and Technology interventions aimed to build, empower progressive and resilient communities with beneficiaries as communities in geographically isolated and disadvantaged areas, marginalized sector, communities with conflicts, indigenous people and women's organization;

WHEREAS, the DOST-NCR has set aside funds from its CEST Program to implement GAD's Project (PROJECT) entitled **Development of Peanut Butter and Thermally Processed Bangus Oil** as a source of livelihood for the women of Muntinlupa City and provide support for the Food Processing Course of the MCTI;

WHEREAS, in addition the fund allocated by the GAD for the PROJECT, DOST shall release the amount of **Nine Hundred Fifteen Thousand Eight Hundred Four Pesos (Php915,804.00)** to be expended as allocated in the approved Line Item Budget which includes purchase of machineries and other supplies;

WHEREAS, the City legal interposed no objection to the terms and conditions of the MOA;

NOW, THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the **City Mayor Atty. Jaime R. Fresnedi** to enter into a **Memorandum of Agreement (MOA)** with **Regional Director Jose B. Patalinjug III**, Department Of Science And Technology-National Capital Region (DOST-NCR) for the project entitled development of peanut butter and thermally processed bangus oil as training cum production for Muntinlupa City's various women's producer groups implemented through the **Gender and Development Office (GAD)** and the **Muntinlupa City Technical Institute (MCTI)**.
