WHEREAS, on March 9, 2020, **President Rodrigo R. Duterte** signed Proclamation No. 922 declaring a state of Public Health Emergency throughout the Philippines upon the recommendation of the DOH following the confirmed local transmission of the novel corona virus disease (COVID-19);

WHEREAS, under the Public Health Emergency, relevant government entities shall be capacitated to facilitate the sufficient and immediate access to funding, particularly for all concerned government agencies and local government units, intensify government response and measures such as easing procurement process, mandatory reporting, and enforcing quarantine and disease control prevention measures;

WHEREAS, Republic Act No. 11469 otherwise known as the Bayanihan to Heal as One Act provides that, "**procurement of goods and services may be undertaken in the most expeditious manner which are related to the prevention and mitigation of Covid-19 virus**";

WHEREAS, the **Government Procurement Policy Board (GPPB)** issued GPPB Resolution No. 03-2020 approving the adoption of efficient, effective and expedient procurement procedure during a state of Public Health Emergency and authorizes the Head of Procuring Agency (HOPE) to delegate the awarding of contract under Negotiated Procurement (Emergency Cases) under **Section 53.2** of the 2016 revised IRR and Item (D)(2a) of **Annex "H"** of the same IRR to any official of the procuring entity except to the BAC Chairperson or members pursuant to **Section 11.2.5** of the 2016 revised IRR of RA No. 9184 and other associated issuances or to any other official where there exists conflict of interest, such as those to whom the HOPE has delegated the authority to directly under the foregoing modality;
