A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH A.M. ORETA & CO. WHEREAS, on **December 30, 2020**, the 9th Sangguniang Panlungsod enacted **Ordinance No. 2020-192**, otherwise known as the as the **Supplemental Budget No. 2**, amounting to One Hundred Fifty-Four Million Two Hundred Thirty Thousand One Hundred Seventy-Eight Pesos (Php154,230,178.11) to cover the statutory and contractual obligations covering the 20% Community Development Fund (CDF) for various construction projects which amount shall be taken from the Savings-Unexpended Balance of the city and adopting the CY 2020 Supplemental Annual Investment Program (AIP).;

WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project **Technical Vocational Facility - MCTI (Phase 1) located at Barangay Sucat, Muntinlupa City** in the newspaper of general circulation and likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisement, one (1) bidder submitted letter of intent and application for eligibility and was found eligible on **February 16, 2021**;

WHEREAS, one (1) Bidder who submitted their Bid on **February 16, 2021** passed the Preliminary Examination of Bid at the City Administration Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan. Muntinlupa:

WHEARES, upon post-qualification or careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **A.M. Oreta & Co. Inc.**,^{sole bidder}'s bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to **Ninety-Nine Million Two Hundred Thirty Thousand Seven Hundred Seventy-Five Pesos and 61/100 (Php99,230,775.61)**;

WHEREAS, the project was awarded to **A.M. Oreta & Co. Inc.**, who being the lowest bidder for the project **Technical Vocational Facility - MCTI (Phase 1) located at Barangay Sucat, Muntinlupa City**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 9th Sangguniang Panlungsod, to authorize the **City Mayor Hon. Atty. Jaime R.
