WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the **Supply & Delivery of Ultra Low Volume Fogging Machine & High Performance Fogging Generator** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Five Million Eight Hundred Seventy Three Thousand Seven Hundred Pesos (P5,873,700.00)**(hereinafter called "the Contract Price").

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of Five Million Eight Hundred Seventy Three Thousand Seven Hundred Pesos (P5,873,700.00) or such other sums as may be ascertained, ISHA GLOBAL DISTRIBUTION CORPORATION agrees to the Supply & Delivery of Ultra Low Volume Fogging Machine & High Performance Fogging Generator in accordance with his/her/its Bid.
  - 4. The City Government of Muntinlupa agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


