Contract Agreement

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the Supply, Delivery, Installation of Curtains, Window Blinds, Woodlook Blinds for Various Offices and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Million Nine Hundred Seventy Thousand One Hundred Twenty Eight Pesos & 38/100 (P1,970,128.38)(hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of One Million Nine Hundred Seventy Thousand One Hundred Twenty Eight Pesos & 38/100 (P1,970,128.38)or such other sums as may be ascertained, KSL ENTERPRISES agrees to the Supply, Delivery, Installation of Curtains, Window Blinds, Woodlook Blinds for Various Offices in accordance with his/her/its Bid.
- 4. The City Government of Muntinlupa agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


