THIS AGREEMENT, made this _____ day of ______ JAN ______ 2023 between CITY GOVERNMENT OF MUNTINLUPA with address at City Hall, National Road, Putatan, Muntinlupa City, (hereinafter called the "Entity") and VICVERA BUILDERS INC. with address at Muntinlupa City (hereinafter called the "Contractor").


