Contract Agreement

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the **Supply, Delivery & Repacking of School Supplies for Distribution to Public School Students** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million Sixty Nine Thousand Five Hundred Pesos (P1,069,500.00)**(hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
