AN ORDINANCE GRANTING THE TOTAL AMOUNT OF THIRTY THOUSAND PESOS (PHP30,000.00) OF FINANCIAL ASSISTANCE TO THE ONE (1) FAMILY AFFECTED BY FIRE ON AUGUST 30, 2023 AT NO. 318, TINDALO STREET, DOÑA ROSARIO HEIGHTS, BARANGAY SUCAT, MUNTINLUPA CITY

WHEREAS, Section 16 of the Local Government Code of 1991 states that *“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*;

WHEREAS, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, *“The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx”*;

WHEREAS, on **August 30, 2023** One (1) structure, housing One (1) family, were gutted by fire at **No. 318, Tindalo Street, Doña Rosario Heights, Barangay Sucat, Muntinlupa City**;

WHEREAS, in a final report rendered by the **Social Services Department** on **September 8, 2023**, and received by the **SP Secretariat Office** on **September 13, 2023** the following were noted as casualties of the said fire:

1. One (1) structure;
2. One (1) family;
3. Three (3) individuals;
4. Two (2) Senior Citizens

WHEREAS, the **Social Service Department (SSD)** of the City of Muntinlupa and the **Barangay Chairman of Sucat**, conducted a survey on the victims of the fire to determine the homeowners, renters and sharers, basing the category of victims in accordance with prevailing ordinances, a recommendation on the matter that would entail a total amount of **Thirty Thousand Pesos (Php30,000.00)** financial assistance to be distributed as follows:

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the **10th Sangguniang Panlungsod**, to grant the total amount of **Thirty Thousand Pesos (Php30,000.00)** of Financial Assistance to the One (1) Family affected by Fire on **September 13, 2023** at **No. 318, Tindalo Street, Doña Rosario Heights, Barangay Sucat, Muntinlupa City**.

ENACTED FURTHER, that the **Final Disaster Report** dated **September 8, 2023**, of the **Social Services Department (SSD)** shall be charge to the **70% Department of Disaster Resilience and Management (DDRM)** with **AIP Reference 1000-001-2-921-150-005-001** and **Account Code** of Other MOOE: 5-02-99-990, shall form part of this ordinance with **CN: 2023-22**.

RESOLVED FINALLY, that the herein **Financial Assistance** shall be coursed through the **Philippine National Red Cross** pursuant to **Commission on Election (COMELEC) Resolution 10747**;

ENACTED, by the **10th Sangguniang Panlungsod of Muntinlupa** this **18TH** day of **September 2023**, on its **63rd Regular Session**.
