AN ORDINANCE GRANTING THE TOTAL AMOUNT OF NINE THOUSAND PESOS (PHP9,000.00) OF FINANCIAL ASSISTANCE TO THE THREE (3) FAMILIES AFFECTED BY FIRE ON SEPTEMBER 11, 2023 AT NO. 70 GARCIP COMPOUND, BARANGAY CUPANG MUNTINLUPA CITY

WHEREAS, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, "The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx";

WHEREAS, on September 11, 2023 One (1) structure, housing Three (3) families, were gutted by fire at No. 70 Garcip Compound, Barangay Cupang Muntinlupa , City;

WHEREAS, in a final report rendered by the Social Services Department on -Septembe 11, 2023, and received by the SP Secretariat Office on September 15, 2023 the following were noted as casualties of the said fire:

One (1) structure;
Three (3) families;
Four (4) individuals;

WHEREAS, the Social Service Department (SSD) of the City of Muntinlupa and the Barangay Chairman of Cupang, conducted a survey on the victims of the fire to determine the homeowners, renters and sharers, basing the category of victims in accordance with prevailing ordinances, a recommendation on the matter that would entail a total amount of Nine Thousand Pesos (Php9,000.00) financial assistance to be distributed as follows:

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the 10th Sangguniang Panlungsod, to grant the total amount of Nine Thousand Pesos (Php9,000.00) of Financial Assistance to the Three (3) Families affected by Fire on Septemer 11, 2023 at No. 70 Garcip Compound, Barangay Cupang Muntinlupa City.

ENACTED FURTHER, that the Final Disaster Report dated September 11, 2023, of the Social Services Department (SSD) shall be charge to the 70% Department of Disaster Resilience and Management (DDRM) with AIP Reference 1000-001-2-921-150-005-001 and Account Code of Other MOOE: 5-02-99-990, shall form part of this ordinance with CN: 2023-23.

RESOLVED FINALLY, that the herein Financial Assistance shall be coursed through the Philippine National Red Cross pursuant to Commission on Election (COMELEC) Resolution 10747;
