AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 3 SERIES OF 2023, IN THE AMOUNT OF TWO HUNDRED FORTY-NINE MILLION TWO HUNDRED SIXTY-TWO THOUSAND EIGHT HUNDRED NINETY-THREE PESOS AND 46/100 (PHP249,262,893.46) WHICH AMOUNT SHALL BE TAKEN FROM THE 2022 UNEXPENDED BALANCE (SAVINGS) UNDER THE GENERAL FUND OF THE CITY

WHEREAS, Section 16 of Republic Act No. 7160 or the Local Government Code of 1991 (LGC) provides that, "Every local government shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;"

WHEREAS, Section 16 of Republic Act No. 7160 , supra, provides that, "Every local government shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;"

WHEREAS, Article 99, 2(i) of the implementing Rules and Regulations of the LGC, states that the Sanggunian Panlungsod, "Shall approve the annual and supplemental budgets of the City government and appropriate funds for specific programs, projects, services, and activities of the city, or for other purposes not contrary to law, in order to promote the general welfare of the city and its inhabitants";

WHEREAS, Sections 312 and 319 of the LGC and Article 417 of its implementing Rules and Regulations (LGC-IRR), as amended by Administrative Officer (A.O.) No. 47 series of 1993, "Allow changes in the Annual Budget of the LGU through a supplement in the Annual Budget under specified circumstances and pursuant to the requirements of the LGC and other applicable laws, rules, and regulations";

WHEREAS, the Consolidated Supplemental Annual Investment Program No. 3, CY 2023 duly approved by the Sangguniang Panlungsod through **Resolution No. 2023-325**, indicated that the Supplemental Budget No. 3 amounting to **Two Hundred Forty-Nine Million Two Hundred Sixty-Two Thousand Eight Hundred Ninety-Three Pesos And 46/100 (Php249,262,893.46)** will be utilized for the purchase of Capital Outlays (CO) and Maintenance and Other Operational Expenditure (MOOE) to be implemented by the following Offices/Department:

NOW THEREFORE, BE IT ENACTED, by the **10th Sangguniang Panlungsod** in a Session assembled that:

SECTION 1. Short Title. This Ordinance shall be known as approval of Supplemental Budget No 3, (**SUPBUD3**) series of 2023;

SECTION 2. Source of Funds. The source of funds for the Supplemental Budget No. 3 (SUPBUD3) series of 2023 in the total amount of **Two Hundred Forty-Nine Million Two Hundred Sixty-Two Thousand Eight Hundred Ninety-Three Pesos And 46/100 (Php249,262,893.46)** shall come from the **General Fund**, certified as available savings from the CY 2022 by the City Treasurer and OIC of the City Accounting Department on September 11, 2023l;

SECTION 3. Utilization of Appropriated Fund. The funds herein approved shall be released and utilized strictly in accordance with applicable budgeting, accounting, and auditing laws, rules, and regulations.

SECTION 4. Separability Clause - If for any reason, a part of this Ordinance is declared illegal or invalid, other parts or provisions hereof which are not affected thereby shall remain valid and in full force and effect.

SECTION 5. Repealing Clause - all other existing ordinances, executive orders and administrative regulations or part of parts thereof which are inconsistent with any provision of this Ordinance are hereby repealed or modified accordingly.

SECTION 6. Effectivity – The ordinance shall take effect upon approval.

ENACTED, by the **10th Sangguniang Panlungsod of Muntinlupa** this **25th** day of **September 2023**, on its **64th Regular Session**.
