**AN ORDINANCE GRANTING THE TOTAL AMOUNT OF SEVENTY-EIGHT THOUSAND PESOS (PHP78,000.00) OF FINANCIAL ASSISTANCE TO THE ELEVEN (11) FAMILIES AFFECTED BY FIRE ON OCTOBER 15, 2023 AT 7C ILAYA ST., BARANGAY ALABANG, MUNTINLUPA CITY**

**WHEREAS**, Section 16 of the Local Government Code of 1991 states that *“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*:

**WHEREAS**, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, *“The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx”*;

**WHEREAS**, on **October 15, 2023** four (4) structures, housing eleven (11) families, were gutted by fire at 7C Ilaya St., Barangay Alabang, Muntinlupa City;

**WHEREAS**, in a final report rendered by the **Social Services Department** on **October 16, 2023**, and received by the **SP Secretariat Office** on **October 18, 2023** the following were noted as casualties of the said fire:

1. **Four (4) structures;**
2. **Eleven (11) families;**
3. **Forty (40) individuals;**
4. **Two (2) Children (0-5 years old)**

WHEREAS, the **Social Service Department (SSD)** of the City of Muntinlupa and the **Barangay Chairman of Alabang**, conducted a survey on the victims of the fire to determine the homeowners, renters and sharers, basing the category of victims in accordance with prevailing ordinances, a recommendation on the matter that would entail a total amount of **Seventy-Eight Thousand Pesos (Php78,000.00)** financial assistance to be distributed as follows:

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the **10<sup>th</sup> Sangguniang Panlungsod**, to grant the total amount of **Seventy-Eight Thousand Pesos (Php78,000.00)** Of Financial Assistance To The Eleven (11) Families Affected By Fire On October 15, 2023 at 7C Ilaya St., Barangay Alabang, Muntinlupa City.

ENACTED FURTHER, that the **Final Disaster Report** dated **October 16, 2023**, of the **Social Services Department (SSD)** shall be charge to the **70% Quick Response Fund (QRF)** from the **Department of Disaster Resilience and Management (DDRM)** with **AIP Reference 1000-001-2-921-150-005-001** and **Account Code of Other MOOE: 5-02-99-990**, shall form part of this ordinance with **CN: 2023-27**.

ENACTED FINALLY, that the herein financial assistance is included in the list of **Exempted Activities approved by the Commission on Election** relative to the Conduct of Barangay, Sangguniang Kabataan Election of 2023;

ENACTED, by the **10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa** this **23<sup>rd</sup>** day of **October 2023**, on its **68<sup>th</sup> Regular Session**.
