AN ORDINANCE GRANTING THE TOTAL AMOUNT OF THREE THOUSAND PESOS (PHP3,000.00) OF FINANCIAL ASSISTANCE TO THE ONE (1) FAMILY AFFECTED BY FIRE ON OCTOBER 29, 2023 AT BLOCK 55 LOT 7 UNIT 8, LABRADOR STREET, KATARUNGAN VILLAGE, BARANGAY POBLACION, MUNTINLUPA CITY

WHEREAS, Section 16 of the Local Government Code of 1991 states that *“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*;

WHEREAS, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, *“The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx”*;

WHEREAS, on **October 29, 2023** one (1) structure, housing one (1) family, was gutted by the fire at **Block 55 Lot 7 Unit 8, Labrador Street, Katarungan Village, Barangay Poblacion, Muntinlupa City** ;

WHEREAS, in a final report rendered by the **Social Services Department** on **October 16, 2023**, and received by the **SP Secretariat Office** on **October 18, 2023** the following were noted as casualties of the said fire:

1. One (1) structure;
2. One (1) family;
3. Five (5) individuals;
4. One (1) Senior Citizen

WHEREAS, the *Social Service Department (SSD)* of the City of Muntinlupa and the *Barangay Chairman of Poblacion*, conducted a survey on the victims of the fire to determine the homeowners, renters and sharers, basing the category of victims in accordance with prevailing ordinances, a recommendation on the matter that would entail a total amount of **Three Thousand Pesos (Php3,000.00)** financial assistance to be distributed as follow:

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the 10th *Sangguniang Panlungsod*, to grant the total amount of *Three Thousand Pesos (Php3,000.00)* of Financial Assistance to the One (1) Family affected by Fire on October 29, 2023 at *Block 55 Lot 7 Unit 8, Labrador Street, Katarungan Village, Barangay Poblacion, Muntinlupa City.*

ENACTED FURTHER, that the Final Disaster Report dated November 3, 2023, of the Social Services Department (SSD) shall be charge to the 70% from the Department of Disaster Resilience and Management (DDRM) Fund with AIP Reference 1000-001-2-921-150-005-001 and Account Code of Other MOOE: 5-02-99-990, shall form part of this ordinance with CN: 2023-029.

ENACTED, by the 10th *Sangguniang Panlungsod of Muntinlupa* this 13th day of November 2023, on its 70th Regular Session.
