ORDINANCE NO. 2023-129

AN ORDINANCE PROVIDING FOR EXEMPTION FROM THE PAYMENT OF PARKING FEES FOR SENIOR AND PERSON WITH DISABILITY (PWD) WHO ARE DROPPED OFF AND PICKED UP IN ESTABLISHMENTS WITHIN THE CITY OF MUNTINLUPA, AMENDING FOR THIS PURPOSE SECTION 3 OF ORDINANCE 17-050 OTHERWISE KNOWN AS THE AN ORDINANCE URGING ALL OPERATORS AND OWNERS OF ESTABLISHMENTS OF PAY PARKING AND THE LIKES, TO EXEMPT THE SENIOR CITIZENS AND PERSONS WITH DISABILITY IN THE PAYMENT OF PARKING FEES

WHEREAS, the fundamental law of the Philippines recognizes the invaluable contribution of the elderly in the formation and growth of the nation. In the same breath, persons with disability (PWD) are sources of inspiration and should be accorded the same treatment as the seniors;

WHEREAS, on 16 January 2017, the Sanggunian Panlungsod enacted Ordinance 17-050 also known as, *An Ordinance Urging All Operators And Owners Of Establishments Of Pay Parking And The Likes, To Exempt The Senior Citizens And Persons With Disability In The Payment Of Parking Fees*;

WHEREAS, Section 3 of Ordinance 17-050 should include free parking to those elderly and PWD who are picked up or dropped off in the establishments within the jurisdiction of the City of Muntinlupa;

NOW THEREFORE BE IT ENACTED, by the 10th Sangguniang Panlungsod of Muntinlupa in session assembled that:

SECTION 1. Section 3 of Ordinance 17-050 which reads as follows:

Section 3. "Availment of parking fee exemption- The parking fee exemption for senior citizen and Persons with Disability(PWD) shall be availed by a senior citizen and PWD driving a vehicle or on board a privately owned vehicle upon presentation of his/her valid senior citizen's and persons with disability Identification card issued by any government agency/office."

IS HEREBY AMENDED TO READ AS FOLLOWS:

SECTION 3. Availment of parking fee exemption - The parking fee exemption for **Senior Citizen** and **Persons with Disability (PWD)** shall be availed by a **Senior Citizen** and **PWD** driving a vehicle or on board a privately owned vehicle upon presentation of his/her valid **Senior Citizen's** and **Persons With Disability** Identification Card (ID) issued by any government agency/office. **Free parking privileges shall also apply to seniors and PWDs who were dropped off and picked up in any establishments within the City of Muntinlupa;**

SECTION 2. Separability Clause – If, for any reason or reasons, any part or provisions of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 3. Repealing Clause. All previous ordinances inconsistent with this ordinance shall be deemed repealed or modified accordingly.

SECTION 4. Publication. This Ordinance shall be published pursuant to the requirements of the Local Government Code and shall be posted by the Public Information Office (PIO) in the Official Website of the City Government of Muntinlupa and in all available social media platforms.

SECTION 5. Effectivity Clause – This ordinance shall take effect after its completion of its publication in a newspapers of general circulation.
