AN ORDINANCE GRANTING THE TOTAL AMOUNT OF ONE HUNDRED FORTY-FIVE THOUSAND PESOS (PHP145,000.00) OF FINANCIAL ASSISTANCE TO THE TWENTY FOUR (24) FAMILIES AFFECTED BY FIRE ON DECEMBER 2, 2023 AT BARANGAY CUPANG, MUNTINLUPA CITY

WHEREAS, Section 16 of the Local Government Code of 1991 states that *“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*:

WHEREAS, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, *“The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx”*;

WHEREAS, on *December 2, 2023* six (6) structures, housing twenty four (24) families, was gutted by the fire at *Barangay Cupang, Muntinlupa City*;

WHEREAS, in a final report rendered by the *Social Services Department* on *December 2, 2023*, and received by the *SP Secretariat Office* on *December 4, 2023* the following were noted as casualties of the said fire:

1. Six (6) structures;
2. Twenty Four (24) families;
3. Sixty Eight (68) individuals;
4. Three (3) Senior Citizens;
5. Six Children (0-5 years old)

WHEREAS, the **Social Service Department (SSD)** of the City of Muntinlupa and the **Barangay Chairman of Cupang**, conducted a survey on the victims of the fire to determine the homeowners, renters and sharers, basing the category of victims in accordance with prevailing ordinances, a recommendation on the matter that would entail a total amount of **One Hundred Forty Five Thousand Pesos (Php145,000.00)** financial assistance to be distributed as follow:

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the **10th Sangguniang Panlungsod**, to grant the total amount of **One Hundred Forty-Five Thousand Pesos (Php145,000.00)** of Financial Assistance to the Twenty Four (24) Families affected by Fire on **December 2, 2023** at **Barangay Cupang, Muntinlupa City**.

ENACTED FURTHER, that the **Final Disaster Report** dated **December 2, 2023**, of the **Social Services Department (SSD)** shall be charge to the **70%** from the **Department of Disaster Resilience and Management (DDRM) Fund** with **AIP Reference 1000-001-2-921-150-005-001** and **Account Code of Other MOOE: 5-02-99-990**, shall form part of this ordinance with **CN: 2023-032**.

ENACTED, by the **10th Sangguniang Panlungsod of Muntinlupa** this **4th** day of **December 2023**, on its **73rd Regular Session**.






