**WHEREAS**, Section 16 of the Local Government Code of 1991 states that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

**WHEREAS**, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, "The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx";

**WHEREAS**, on December 2, 2023 a fire happened at No. 55, Purok 1, Barangay Cupang, Muntinlupa City, which caused great loss of properties and economic resources of the affected residents;

**WHEREAS**, the Social Services Department (SSD), through the letter addressed to City Mayor Rozzano Rufino B. Biazon, dated 07 December 2023, endorsed to and received by the SP Secretariat Office on 13 December 2023, recommended the financial assistance to the additional one (1) affected family, as categorized based on the survey conducted with the Chairman of Barangay Cupang;

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the **10<sup>th</sup> Sangguniang Panlungsod**, to grant the total amount of **Five Thousand Pesos (Php5,000.00)** of Financial Assistance to the additional one (1) family affected by fire on December 2, 2023 at No. 55, Purok 1, Barangay Cupang, Muntinlupa City.

ENACTED FURTHER, that the **Financial Assistance** detailed on the **Final Disaster Report** dated **December 2, 2023**, of the **Social Services Department (SSD)** shall be charged accordingly to the **70%** of the **Department of Disaster Resilience and Management (DDRM) Fund** with **AIP Reference No. 1000-001-2-921-150-005-001** and **Account Code of Other MOOE: 5-02-99-990**, shall form part of this ordinance with **CN: 2023-032**.

ENACTED, by the **10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa** this **18<sup>th</sup>** day of **December 2023**, on its **75<sup>th</sup> Regular Session**.
