AN ORDINANCE GRANTING THE TOTAL AMOUNT OF FIFTY THOUSAND PESOS (PHP50,000.00) OF FINANCIAL ASSISTANCE TO THE SEVEN (7) FAMILIES AFFECTED BY FIRE ON DECEMBER 16, 2023 LOCATED AT NO. 2310 QUARRY SATELLITE, BARANGAY POBLACION, MUNTINLUPA CITY

WHEREAS, Section 16 of the Local Government Code of 1991 states that *“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*:

WHEREAS, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, *“The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx”*;

WHEREAS, on *December 16, 2023* three (3) structures housing, seven (7) families, was gutted by the fire located at *No. 2310 Quarry Satellite Barangay Poblacion, Muntinlupa City*;

WHEREAS, in a final report rendered by the *Social Services Department* on *December 18, 2023*, and received by the *SP Secretariat Office* on *December 18, 2023* the following were noted as casualties of the said fire:

1. *Three (3) structures*;
2. *Seven (7) families*;
3. *Twenty-Two (22) individuals*;

WHEREAS, the *Social Service Department (SSD)* of the City of Muntinlupa and the *Barangay Chairman of Poblacion*, conducted a survey on the victims of the fire to determine the homeowners, renters and sharers, basing the category of victims in accordance with prevailing ordinances, a recommendation on the matter that would entail a total amount of **Fifty Thousand Pesos (Php50,000.00)** financial assistance to be distributed as follows:

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the 10th *Sangguniang Panlungsod*, to grant the total amount of **Fifty Thousand Pesos (Php50,000.00)** of Financial Assistance to the Seven (7) Families affected by fire on December 16, 2023 located at **No. 2310 Quarry Satellite Barangay Poblacion, Muntinlupa City.**

ENACTED FURTHER, that the **Final Disaster Report** dated **December 18, 2023**, of the **Social Services Department (SSD)** shall be charge to the 70% from the **Department of Disaster Resilience and Management (DDRM) Fund with AIP Reference 1000-001-2-921-150-005-001 and Account Code of Other MOOE: 5-02-99-990**, shall form part of this ordinance with **CN: 2023-034.**

ENACTED, by the 10th *Sangguniang Panlungsod of Muntinlupa* this 18th day of **December 2023**, on its 75th *Regular Session.*
